ACCIDENT WAIVER AND RELEASE OF LIABILITY

I acknowledge that this Accident Waiver and Release of Liability form will be used by the event holders, vendors, sponsors and organizers, in which I am may participate in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release and Discharge from liability for my death, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me including my traveling to and from this event, Steve Schmall, NPC Utah, National Physique Committee of the USA, Inc. (NPC), Cottonwood High School, their associated bodies, directors, officials, employees, volunteers, representatives, and agents, the event holders, event sponsors, event directors, event vendors; (B) Indemnify and Hold Harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this event, whether caused by negligence of release or otherwise.

I hereby consent to receive medical treatment that may be deemed advisable in the event of injury, accident and/or illness during this event.

And further consideration of permission being granted to me to participate in the 2010 NPC UTAH OPEN BODYBUILDING, FIGURE AND BIKINI CHAMPIONSHIPS and their related events (the Event), receipt of which benefit is hereby acknowledged, I hereby grant you, Steve Schmall, NPC Utah, NPC, and all video and entertainment organizations, and all their agents, successors, licenses and assigns, the right to photograph or otherwise reproduce (whether by film, tape, still photography or otherwise) my voice, appearance and name, and to exhibit, distribute, transmit, and/or exploit any and all such reproductions containing my voice and/or appearance in all media, including without limitation, by means of still photography, motion pictures, video, printing or any other media known or hereafter devised, including also with respect to merchandising, advertising and/or publicity, and the right to use my name and information about me in any connection with the foregoing.
